The Supervisory Authority of the Netherlands, on behalf of the Appropriate Authority of the Netherlands, would like to inform Lineas Aereas Suramericanas SA, as Regulated Agent Third Country, with regard to the designation from the Appropriate Authority into the Union database pursuant to the points of chapter 6.8, including but not limited to, point 6.8.4.1., 6.8.4.5. and 6.8.4.6. Commission Implementing Regulation (EU) 2015/1998.

The Supervisory Authority of the Netherlands has decided to notify Lineas Aereas Suramericanas SA with regard to the validity of the designation, based on the submitted validation report by S. de Man (EU aviation security validator) including the declaration of commitments as set out in Attachment 6-H2, the checklist set out in Attachment 6-C2 and a declaration by the EU aviation security validator as set out in Attachment 11-A, and has allocated the maximum period of three years as of the 10th of march 2020, pursuant to point 6.8.4.6., Commission Implementing Regulation (EU) 2015/1998. Lineas Aereas Suramericanas SA is thus validated and approved on the basis of an EU aviation security validation.

After the security controls are applied Lineas Aereas Suramericanas SA shall ensure that the accompanying documentation indicates the following allocated unique alphanumeric identifier: CO/RA3/000011-01. During the aforementioned designated period, Lineas Aereas Suramericanas SA shall comply with Union legislation, (other) applicable legislation(s) and regulation(s) and the Declaration of Commitments (third country EU aviation security validated Regulated Agent).

The designation as Regulated Agent Third Country is valid for three years and will expire on the 9th of march 2023 at the latest. It is imperative that a request for a renewal of the designation should be made well in advance prior to the abovementioned expiry date.

The supervisory (legal) powers that are applicable with regard to the Supervisory Authority of the Netherlands in reference to the Regulated Agent Third Country, are in force.
